On October 15, 2008, Presbyterian Intercommunity Hospital, Inc. (the "Borrower") released a Disclosure of Intent to Bid (the "Notice") as a preliminary statement of the Borrower's intent to bid on the bonds referenced above (the "Bonds") in the auction to be held on October 22, 2008 (the "Auction"). The purpose of this Post-Auction Disclosure is to supplement the Notice with certain bid results of the Auction.

Post-Auction Disclosure Is Hereby Given That:

- (1) On Wednesday October 22, 2008 the Borrower submitted a bid in the Auction to hold on \$56,475,000 of Bonds purchased at the April 23, 2008 through October 8, 2008, auctions and to bid to purchase the \$7,525,000 of the remaining Bonds subject to auction. The Borrower bid an interest rate of 2.450% which was the then current SIFMA Municipal Swap Index of 3.45% minus 100 basis points. The Borrower was able to purchase \$ 150,000 of the Bonds available at Auction. The Borrower presently intends to submit Hold Orders in subsequent auctions with respect to the Bonds which it owns.
